Is the FA aware that Mr Peter Hargitay's ECN company is registered in Limassol, Cyprus? Is the FA happy about this?

We are satisfied that we have been accurately and properly advised from the outset about ecn's legal status and its registered headquarters in Cyprus. Prior to commencement the consultancy work, ecn completed the due diligence document we submitted to them. We are also aware of ecn's fully owned subsidiary, a company registered in the Canton of Zurich, Switzerland.

What is the relationship between Mr Peter Hargitay and the ABI Agency of 81 Lavaterstrasse, Zurich? (He currently gives an ABI number as his point of contact in Zurich)

We have been advised by ecn that there is no relationship between the two companies other than the fact that ecn were renting office space at the address a few years ago, before a subsidiary was formed, and at that time used the telefax services of the main tenant, ABI.

In addition, ecn have also informed us that the number now belongs to ecn and not ABI, and will ask ABI to remove it from their contact details on their website.

There are overwhelming similarities between the biog/CV that Mr Hargitay currently distributes and the biog/CV of the 'senior partner & managing partner offshore business' featured on the abi companies website at: <http://>

Mr Hargitay has confirmed to us that he is not that person.

Will the FA be using the advertised 'surveillance' skills of the ABI company to monitor the FIFA ExCo members who will vote on which country hosts the 2018 World Cup?

The FA has not engaged ABI in any form and would not use that type of service as part of our bid campaign. As we made clear at the time, ecn were appointed because of their background in world football, their wide range of contacts and the know-how they have acquired of iw FIFA and the World Cup bidding process work.
